Having regard to the consultation of the Management Board of the college authorising the head of the establishment to conclude on behalf of the establishment any agreement that pertains to periods of training in the workplace in accordance with the standard agreement;

## Article 1 – Purpose of the agreement

The purpose of this agreement is to put in place, for the benefit of the pupil or student trainee, a workplace based training course that is mandatory under the official reference system for the diploma for which they are studying, within the framework of the initial training under school status for which they are registered.

#### **Article 2 – Provisions of the agreement**

The agreement comprises general provisions constituted by Appendix 1 and specific provisions of a financial nature constituted by Appendix 2. These provisions shall apply to this agreement unless the law of the flag of the vessel upon which the trainee has embarked provides provisions that are more favourable to the trainee.

Appendix 1 sets out the standard provisions for the organisation of the maritime workplace training period for the trainee in the host organisation, as well as the insurance arrangements. Appendix 2 sets out the arrangements for meeting the costs of the period.
